

# LIVING LARGE STALLION

## 2025 BREEDING CONTRACT

All rights and responsibilities between the Parties for the 2024 breeding season are as follows:

1. Mare Owner agrees to breed:

- a. PLEASE NOTE: Living Large is an Appendix registered Stallion with AQHA (has an "X" in front of his registration number). If the mare is an Appendix registered mare (has a "X" in front of her registration number), the resulting foal will not be able to be registered as a Quarter Horse

To the Stallion, Living Large: APHA #971,497 and AQHA # X0686430 herein referred to as "Stallion") during the 2025 breeding season commencing February 15<sup>th</sup>, 2025, and ending July 15, 2025. Mare Owner agrees to pay the breeding fee of \$1,750.

**PLEASE NOTE: Once this contract is fully signed, this breeding cannot be sold or transferred to another mare owner UNLESS a new contract has been fully signed by the new mare owner and the new mare papers have been received. If the breeding is sold to another mare owner and the new contract has not been fully signed and new mare papers are not received BY THE BREEDING DATE, the resulting foal will not be eligible to be registered until the mare owner has paid \$200 to cover late breeding report costs.**

2. BREEDING FEES: (U.S. DOLLARS) **Check to be made out to Living Large LLC**

\_\_\_\_\_ \$300 (Three hundred dollars) discount is given for:

- World Champion Mares
- Reserve Champion Mares
- World Champion Producing Mares

\_\_\_\_\_ \$250 Discount is given for repeat (consecutive years only) breedings.

NOTE: Maximum discount to be applied is \$500.

NOTE: The payments provided in paragraph 2 are for one foal for this breeding season from this Mare. Should more than one embryo or foal result from a breeding, Mare Owner shall pay an additional Breeding Fee of \$1,750 for each embryo or resulting foal. No breeding certificate for any foal shall be issued without such additional payment.

3. INTERNATIONAL MARE OWNERS: **The breeding fee must be paid by wire only. For wire information, please contact us and that information will be emailed to you. Please note, we cannot ship semen to Canada at this time.**
4. CHUTE FEE: \$400.00 (US MARE OWNERS ONLY: Only applicable if the breeding was purchased through another source- (auction or sale)) **Check to be made out to Living Large LLC**
5. US SHIPPING FEES (please check one): **Check to be made out to Dr. Kory Niswender and must be received before semen is shipped**
  - Counter to counter airport carrier fee \$650.
  - Shipped semen via Federal Express, UPS or other next day courier \$325 + freight.
  - Shipped Frozen Semen \$400
  - Picked up semen at \_\_\_\_\_ (your container) \$200.
  - Purchase disposable shipping container \$45.

Mare Owner is responsible for returning non-disposable container to Dr. Niswender at the Mare Owner's expense within 5 days of receipt. After 5 days Mare Owner will be charged \$20 daily rental. Breeder makes no representation or warranties, express or implied, regarding the delivery of the Cooled Semen delivered under this Breeding Contract, and shall not be responsible for delayed, lost, or mishandled deliveries.
6. MARE BREEDING CONDITION: Mare Owner warrants and represents that Mare is in sound breeding condition, free from any infection, or disease. In the opinion of the attending veterinarian and at the sole discretion of the attending veterinarian, any Mare determined not to be in sound Breeding Condition shall not be bred to Stallion. Upon that determination, Mare Owner may substitute another Mare for Breeding to Stallion, subject to all the terms and conditions of this Breeding Contract.
7. SEMEN HANDLING: Mare Owner agrees to comply with all AQHA/APHA or other pertaining breed requirements, as applicable, concerning the use and handling of cooled semen. Frozen semen is available on high volume days, inclement weather, and, if Stallion is gone to a select set of shows. A qualified, experienced, and licensed veterinarian competent in the use and handling of cooled or frozen semen should perform the insemination. The Breeder, in its sole discretion, may refuse to ship semen beyond three shipments, if the Breeder believes the insemination is not proper, or the Mare is not healthy. Semen will be collected only on established Breeding days and no representations or warranties are made or implied that Cooled Semen will be available at the time requested by the Mare Owner.

8. LIVE FOAL GUARANTEE: "Live Foal" is defined as a foal born alive that stands and nurses. It is understood that if a Mare proves barren, aborts her foal, or if the foal is stillborn or otherwise does not meet the definition of "live foal", Mare Owner is guaranteed one (1) return breeding in 2024 for a re-breed booking fee of \$400. Written notification within one week of foal loss from a licensed veterinarian is required to certify the loss.
9. COLOR GUARANTEE: The resulting foal from the Breeding of the above-named APHA Mare must be eligible for Registration in the appropriate breed. If the resulting foal is not eligible based on color requirements for Registration, the above-named Mare Owner is guaranteed a slot to breed a Mare of his/her choice the following Breeding year only. There shall be a rebreed fee of \$850.
- 10 BREEDERS CERTIFICATE: A Breeders Certificate produced by the appropriate Association shall be issued to the Mare Owner as shown on the Mare Registration Papers, after all fees and expenses have been paid in full, and upon notification to Stallion Manager of the birth.
- 11 If the Stallion dies or is sold or becomes incapable of servicing mares for any reason, and mare has not been bred, all fees accrued will be due and the Parties to this Agreement will be released from further liability.
- 12 WAIVER OF LIABILITY, RELEASE AND HOLD HARMLESS: MARE OWNER HEREBY AGREES THAT BREEDER, AS WELL AS ITS' AGENTS, EMPLOYEES, OFFICERS, VETERINARIANS, GUESTS (THE RELEASED PARTIES), SHALL NOT BE LIABLE AND SHALL BE RELEASED AND HELD HARMLESS FROM ANY AND ALL CLAIMS, CAUSES OF ACTIONS, EXPENSES AND DAMAGES OF ANY NATURE RESULTING FROM, OR RELATING TO ANY EXCAPE, ACCIDENT, INJURY, SICKNESS, DISABILITY AND/OR DEATH OF MARE AND/OR FOAL, AS WELL AS, ANY EXERCISE OF JUDGMENT BY THE RELEASED PARTIES IN CONNECTION WITH THE CUSTODY AND CARE OF THE MARE AND/OR FOAL.

MARE OWNER UNDERSTANDS AND SPECIFICALLY REPRESENTS THAT THE PROTECTION FOR MARE OWNER TO COVER ANY POTENTIAL LOSS REGARDING MARE AND/OR FOAL IS TO OBTAIN INSURANCE FOR SUCH LOSS. MARE OWNER UNDERSTANDS IT IS THE MARE OWNER'S RESPONSIBILITY AND CHOICSE WHETHER TO OBTAIN SUCH INSURANCE.

- 13 REGISTRATION PAPERS: Mare Owner shall provide Breeder a copy of Mare's Registration papers (front and back) at the time of the execution of this Breeding Agreement. The Owner of Record on the registration papers shall be the owner recorded on the Stallion Breeding Report.
- 14 VENUE AND JURISDICTION: All disputes related to this Breeding Contract shall be governed by the laws of the State of Texas. Mare Owner agrees that personal jurisdiction and venue of all such disputes shall appear in Parker County, Texas.

\*\*\*\*\*FOR US MARE OWNERS ONLY: By signing this contract, the mare owner understands that Living Large is collected Mondays, Wednesdays, and Fridays from January 15<sup>th</sup> through July 15 of

the breeding year. Furthermore, the mare owner understands that all shipping requests must be made THE DAY BEFORE you wish semen to be shipped. All requests for semen shipments must be placed with Dr. Kory Niswender at 817-304-2897\*\*\*\*\*

PLEASE NOTE: INTERNATIONAL ORDERS ONLY CAN BE PROCESSED WITH A WIRE TRANSFER. PLEASE CONTACT US FOR DETAILS
